QUEZON CITY SCIENCE HIGH SCHOOL, a government educational institution organized and existing by virtue of DECS Order No. 58, s. 1999, as amended, with principal office address at Golden Acres Road corner Misamis Street, Bago Bantay, Quezon City, duly represented herein by its School Principal, REMEDIOS P. DANAO, and herein referred to as the "QCSHS";

UNIVERSITY OF THE PHILIPPINES, the National University, created by virtue of Republic Act 1870, as amended and strengthened by Republic Act No. 9500, otherwise known as "The University of the Philippines Charter of 2008" through its Constituent University of the Philippines, with official address at University of the Philippines Diliman, Quezon City, represented by its Chancellor, FIDEL R. NEMENZO, hereinafter referred to as the "UNIVERSITY";

#### WITNESSETH THAT:

**WHEREAS**, the QCSHS is mandated by the Department of Education to provide for a more intensive and advanced secondary education program with special reference to science;

**WHEREAS**, the UNIVERSITY, has a tradition of excellence in research and education and offers state-of-the-art physical facilities and instrumentation;

WHEREAS, the QCSHS, through the SCIENCE IMMERSION PROGRAM (SIP), exposes its scholars to actual scientific research or research projects done either in the laboratory or in the field with the goal of motivating the scholar to pursue a course and a future career in science and technology;

WHEREAS, the UNIVERSITY has the scientific equipment, laboratory and expertise that can expose and train the QCSHS's scholars to extensive and in-depth scientific research;

**WHEREAS**, the UNIVERSITY, upon request of the QCSHS, has expressed its willingness to be a collaborating agency for the SIP **2020-2022**;

**NOW, THEREFORE,** for and in consideration of the foregoing premises, the parties agree to be bound by the following terms and conditions:

1. **PURPOSE:** The following objectives are set forth in the execution of this Memorandum of Agreement:

- e. Should the participating UNIVERSITY unit requires the student-interns to undergo safety training, a contract shall be prepared and agreed upon by both parties.
- f. In compliance to the Data Privacy Act of 2012, personal information which includes photo submitted by the student shall only be used for SIP purposes, and shall not be shared/ transferred without prior written consent of QCSHS and the data subject. The UNIVERSITY further warrants that measures are in place to prevent the unauthorized use or disclosure of the personal information submitted. The QCSHS upon the request of the UNIVERSITY shall also secure photo/video release form that would cover documentation photos/videos of the SIP activities.

#### LIABILITY

- a. The QCSHS shall hold the UNIVERSITY free from any liability for any injury or damage to property caused by the negligent or accidental act or omission of the participating scholar.
- b. For the duration of the SIP, the participating scholar shall be solely liable for any injury and/or damage to property caused by him/her through his/her negligence or inadvertence.
- c. The QCSHS shall be responsible in ensuring that the participating scholar will replace or cause the repair of the property damaged by him/her caused by his negligence or inadvertence.

# 6. INFORMATION SHARING AND OWNERSHIP AND USE OF INTELLECTUAL PROPERTY RIGHTS

- a. The QCSHS and the participating scholar shall not use for their own benefit in any work, research or project any data, concept, information or idea gathered or obtained during the SIP 2020-2022 without the expressed written consent of the UNIVERSITY;
- b. Should the UNIVERSITY allow the use of any data or information as mentioned in the immediate preceding paragraph, the QCSHS and/or the participating scholar shall expressly acknowledge the UNIVERSITY as owner or source of the work, research or project.
- c. Should the UNIVERSITY allow the use of any data or information as mentioned on the immediate of preceding paragraph, the QC\$HS shall request a written consent from the host institution to present/publish data and co-authorship (with assisting researchers/Research Assistants/faculty member/s) in any conference presentation or publication.
- d. Any benefit accruing to the generation of the intellectual property out of a research or project covered by this agreement shall be governed by
